

HYDROGRAPHIC (BATHYMETRIC) DATA WERE COLLECTED UTILIZING A COMBINATION OF AN TELEDYNE E20 SURVEY GRADE SOUNDER WITH A 200KHZ TRANSDUCER AND AN R2SONIC MODEL 2022 MULTIBEAM SOUNDER AND MOTION STABILIZED WITH AN SBG EKINOX-D INERTIAL NAVIGATION SYSTEM IN CONJUNCTION WITH REAL TIME KINEMATIC GPS METHODOLOGIES WITH BROADCAST CORRECTIONS FROM A CONVENTIONAL GPS BASE STATION AND ARE ACCURATE TO THIRD ORDER, CLASS II.

BATHYMETRIC SURVEY CONTOUR CHART COVER SHEET JUPITER - PALM BEACH COUNTY, FLORIDA


